St. Mary's County Sheriff's Office – Has suggested members keep their doors always locked while at home if possible. Keep automobiles locked when parked. There have been a few cases with people going through automobiles at night and people walking into member's homes. Protect yourself and your property.

Code Enforcement – Are checking homes in Country Lakes for automobiles with no registration/tags. It is unlawful to store any automobiles, trailers, boats on your property that is not registered/not tagged.

Lighted Sign Rental – If you want something stated on the lighted sign at the park. Please go to website to contact the Event Coordinator to make arrangements. The message is for a 24-hour period. Member dues must be paid in full. All rentals are at the discretion of the board for approval. No political messages will be allowed.

Dues Management – Country Lakes Dues statement will be mailed out the first of June and dues back July 1. Any member behind in their dues are subject to be forwarded to our attorney for collection. Once a member is turned over, the members account is no longer in the hands of the dues manager. All concerns will be directed to our attorney. If the members account has been turned over, the member will be responsible for attorney fees, all cost associated with collection of this account.
